



Mississippi State University Annual Income Tax Course

Registration Fees:

\$275 if postmarked by November 23
\$300 if postmarked after November 23

Registration fees for the 15-hour, 2-day course includes all course materials, a continental breakfast, and afternoon refreshment breaks.

Cancellations: If you need to cancel your registration for a course, you must request a cancellation in writing by December 1, 2009. Participants who cancel by December 1, will receive a refund less a \$50 cancellation fee. Cancellations received after December 1 are not eligible for a refund.

If a course is cancelled by Mississippi State University/Tax Insight, participants will receive a full refund.

Location Transfers: Locations cannot be transferred after November 30, 2009.
